I HAVE READ THE STUDIO POLICY AND IT IS MY UNDERSTANDING THAT:

- 1. Tuition is due the first of each month. A late fee of \$10 will be assessed on the 11th of the month on any unpaid tuition balance.**
- 2. If I decide to withdraw my child from dance class(es), it is my responsibility to notify the studio office. Failure to do so will result in continued monthly charges. Participation in any classes the month the child withdraws results in a charge for the ENTIRE month.**
- 3. There are no REFUNDS for missed classes. Make-up classes are available.**
- 4. A \$45 NON-REFUNDABLE costume deposit for each class is due between October 1 and November 15. The balance of all costume charges is due during the month of March. Your child's costumes will not be ordered until their costume deposits are paid. REMEMBER: ALL COSTUME DEPOSITS ARE DUE BY NOVEMBER 15TH AND THE BALANCES ARE DUE BY MARCH 31ST.**
- 5. Costumes are ordered in January. If my child withdraws from dance class(es) after January 1st, I am still responsible to pay the balance of the costume charge(s).**
